

<b>U.S. DEPARTMENT OF HOMELAND SECURITY</b> U.S. Coast Guard CG-5200A (Rev. 02-10)		<b>ETHNICITY AND RACE SELF-REPORTING WORKSHEET</b>	
<b>Purpose:</b> Federal standards emphasize self-reporting or self-identification as the preferred method for collecting data on race and ethnicity. The standards do not establish criteria or qualifications (such as blood quantum levels) that are to be used in determining a particular individual's racial or ethnic classification. They do not tell an individual who he or she is, or specify how an individual should classify himself or herself. Self-identification for race and Hispanic or Latino origin means that the responses are based on self-perception and therefore are subjective, but by definition, the responses are accurate. Because <b>the standards allow individuals to report one or more races</b> , the importance of self-identification is underscored; it is generally difficult for observers to report an individual's multiple racial heritages.

Mark one or more races in Section I and then refer to the table on the reverse or next page of this worksheet to determine the corresponding "Diversity Description". The Diversity Description is an abbreviation used in PeopleSoft to record racial heritage.</li> <li>2. Mark one of the choices in Section II.</li> <li>3. If you can access PeopleSoft, log into the system and update your diversity data using the self-service menu. If you cannot access PeopleSoft, complete the identification data at the bottom of this worksheet, sign, date and forward it to your Servicing Personnel Office for data entry.</li> </ol>
